Pursuant to the orders passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 4593/2022 dated 14-07-2022 titled as Amit Kapil Vs. HP University & Another, the Vice Chancellor constituted a Committee vide Notification No. 3-29/94-HPU(Genl.) Vol-VII dated 19-07-2022 to re-consider the Policy and Programme as already notified vide notification of even number dated 12-12-2019 with regard to framing of Policy and Programme for the appointment of Assistant Professor, Associate Professor and Professor in the University/Colleges as per UGC Regulations 2018.

Accordingly, the Vice-Chancellor on the recommendations of the Committee dated 02-08-2022 is pleased to make following amendment in clause "4. Shortlisting for interview in the Policy and Programme for appointment of Assistant Professor in the University/Colleges as under:

## 4. Shortlisting for interview:

Candidates shall be invited for an interview in order of merit according to marks obtained by them in the Academic Score Component (Tally Sheet) accordingly to following criteria:-

- (i) For one vacancy, maximum of 20(Twenty) candidates shall be invited. For every additional vacancy a maximum of 10(ten) additional eligible candidates be invited. Vertical reservation will be applicable as per roster.
- (ii) Even in case of single candidate in horizontal reservation and as per the policy and programme of the University and ensuring proper representation to the post reserved horizontally, will be eligible for screening for the advertised post. As a consequential effect, the concerned candidate for horizontally reserved category will be eligible for consideration for the said post.

The notification issued vide notification of even number dated 01-08-2022 is hereby withdrawn. However, the other contents of the Policy and Programme for the appointment of Assistant Professor in the University/Colleges as notified vide notification dated 12-12-2019 shall remain unchanged.
